



QUEST FOR THE LOST CONSOLE SWEEPSTAKES

OFFICIAL RULES

DISCLAIMER: PLEASE READ THESE OFFICIAL RULES CAREFULLY. PARTICULARLY, PLEASE NOTE CAREFULLY THE ELIGIBILITY, THE SUBMISSION CRITERIA, THE LIMITS OF LIABILITY AND THE USE OF PERSONAL INFORMATION SECTION OF THESE RULES. THE SPONSOR RESERVES ITS DISCRETION TO DISQUALIFY A PARTICIPANT IF IN ITS OPINION THESE OFFICIAL RULES ARE NOT COMPLIED BY A PARTICIPANT.

The Quest for the Lost Console Sweepstakes (the “Sweepstakes”) is subject to these Official Rules (“Official Rules”), which are binding and final on matters relating to the Sweepstakes, except as expressly stated otherwise. **No purchase necessary to enter or win.** The Sweepstakes is sponsored by Gen.G (the “Sponsor”).

1. How to Enter:

- Puzzle Challenges: Entrants can enter the Puzzle Challenges Sweepstakes by filling out their name and email on the official Sweepstakes homepage and completing puzzle challenges (“Puzzle Challenges”) on the official Sweepstakes website, www.1PasswordConsoleQuest.gg, between May 24th, 2022 and June 17th, 2022.
- Campaign Social Sweepstakes:
 - Entrants can enter the Campaign Social Sweepstakes on Twitter and Instagram based on the applicable call to action announced by Sponsor on May 30th, 2022 through June 7th, 2022 with the hashtag #Quest4LostConsole on official Quest for the Lost Console Sweepstakes posts on @Gen.G Twitter and @1PasswordOfficial Instagram (“Submission”) during the Sweepstakes Period. (“Online Entry”)
 - Entrants can enter the Campaign Sweepstakes by replying on Twitter and Instagram and completing the respective actions.
 - Any attempt by any person to obtain more than the stated number of Entries by using multiple/different accounts, or any other



methods including, without limitation, script, macro or any automated or other means which subverts the entry process, will void all of that person's entries and that person will be disqualified. Any user not using their main social account for entry (I.E. Giveaway accounts), will void all entries and cannot win these sweepstakes.

2. Eligibility: All eligible participants are defined as Entrants.

You can participate to win in the Sweepstakes if you are aged 13 years or older residing in the United States of America or Canada (an "Entrant"), excluding residents of Quebec. **One Submission per person for each corresponding call to action. If you are under the age of 18 but at least 13 years of age, you may enter the Sweepstakes only under the supervision of a parent or legal guardian who agrees to be bound by these Official Rules.** If you are a parent or legal guardian agreeing to these Official Rules for the benefit of a child between the ages of 13 and 18, please be advised that you are fully responsible for the child, including any applicable financial charges and legal liability that the child may incur. The Sweepstakes are not directed to children under the age of 13 years. Children under the age of 13 may not enter the Sweepstakes. If Sponsor becomes aware that a child under 13 has provided or attempted to provide us with personal information, Sponsor will use best efforts to remove the information permanently from Sponsor's files.

You can participate to win if you are residing in the United Kingdom, Germany, France, the Netherlands, and Belgium and you are at least 16 years old (an "Entrant"). The Sweepstakes are not directed to children under the age of 16 years. Children under the age of 16 residing in one of these countries may not enter the Sweepstakes. If Sponsor becomes aware that a child under 16 has provided or attempted to provide us with personal information, Sponsor will use best efforts to remove the information permanently from Sponsor's files.

Individuals with a direct business relation with the Sponsor or its Affiliates (defined as third parties directly or indirectly engaged with the Sponsor for the Quest and Sweepstakes) who may have knowledge of Sweepstakes are not eligible to enter or participate in the Contest.

The Sweepstakes are subject to all applicable federal, state and local laws, rules



and regulations. Void where prohibited.

3. Sweepstakes Period: The Quest for Lost Console Sweepstakes periods are listed below. There is one (1) Sweepstakes Period (“Sweepstakes Period”). Entries must be received during their respective Sweepstakes Period to be eligible to win.

- Sweepstakes Period: May 24th, 2022 at 9:00 AM EST until June 17th, 2022 at 11:59 PM EST.

4. Odds: Odds of winning a prize depend on the number of eligible entries received.

5. Prizes: If eligible under these Official Rules, two (2) Entrants will receive a Grand Prize after meeting specified conditions listed below and seventy (70) randomly selected Entrants will receive either:

- Puzzle Challenge #6: Ten (10) randomly selected Entrants
- Puzzle Challenge #7: Ten (10) randomly selected Entrants
- Campaign Sweepstakes Winners
 - The Campaign Sweepstakes will have twenty (20) randomly selected entrants who will receive a one (1) 1 Year 1Password membership and one of the following:
 - Quest for the Lost Console Merchandise
 - ARV: \$30 USD
 - Gaming Peripherals
 - ARV: \$150 USD
- Social Sweepstakes Winners
 - Each selected winner will receive one (1) one (1) year 1Password Membership and either one of the following:
 - Quest for Lost Console Merchandise
 - Gaming Keyboard
 - Gaming Headset
 - The Social Sweepstakes will have Twenty Four (24) randomly selected entrants:
 - Twitter Social Sweepstakes: Nine (9) randomly selected Entrants
 - Instagram Social Sweepstakes: Nine (9) randomly selected Entrants
 - Gleam Social Sweepstakes: Six (6) random selected Entrants

Selected Entrants are not entitled to any surplus between actual retail value of prize and approximate retail value and any difference between approximate and actual value of the prize will not be awarded. No substitution, transfer, or cash redemption of prize, or cash for any portion of prize not used, provided however that Sponsor reserves the right to substitute a prize with another prize of equal or greater value should the advertised prize become unavailable for any reason. If a Selected Entrant does not want a portion of the prize, that portion is forfeited. All additional costs, including taxes, are the sole responsibility of Selected Entrants.

6. Submission Criteria:

- Submissions must be submitted according to the How to Enter section.
- Submissions must be directly accessible by Sponsor.
- Submissions may not depict nudity or any other offensive or obscene subject matter as determined in Sponsor's sole discretion.
- Submissions shall not portray Sponsor in a negative light.



- Submissions must be appropriate for a broad audience.
- You hereby agree to indemnify Sponsor against any and all claims from any third-party for any use by Sponsor of the Submission.
- Although Sponsor is not reviewing Submissions for copyright violations, if, in the sole discretion of Sponsor, it is believed your Submission constitutes or may constitute copyright infringement, the Submission will be disqualified.
- Sponsor may require verification of Submissions through a procedure solely determined by Sponsor at its sole discretion.
- Sponsor reserves the right to exclude any Submission that it believes, in its sole discretion, doesn't meet these criteria or otherwise violates these Rules, and to delete or otherwise remove any such Submission from any and all location(s) under Sponsor's control.
- Each Entrant has only one valid Submission per Puzzle Challenge. Multiple Submissions by the same Entrant for the same Puzzle Challenge shall only be considered as one Submission.
- The use of any kind of cheating device and/or cheat program will be subject to penalties at the discretion of Gen.G.
- **Upon discovery of any Submission committing any violations of the Rules listed above, Gen.G may, without limitation of its authority, issue the following penalties:**
 - **Written Warning**
 - **Prize Forfeiture**
 - **Suspension**
 - **Disqualification**

7. Winner Selection and Notification of Selected Entrants:

- One (1) Entrant will be selected based on the earliest completion time of Puzzle Challenge #7.
- One (1) Entrant will be randomly selected based on the completion of all seven (7) Puzzle Challenges during the Sweepstakes Period on June 24th, 2022.
- Seventy (70) Entrants, up to ten (10) per Puzzle Challenge Prizing Form, will be selected at random by a representative of Sponsor from among all eligible entries received during the Sweepstakes Period on June 24th, 2022; (collectively, "Selected Entrants").

Selected Entrants will be notified by email, phone, or via the platform through which the Submission was made, according to Sponsor's sole discretion and with the information provided at the time of entry. Selected Entrants will be required



to respond (as directed) within three (3) days of attempted notification. The failure to respond within three (3) days to the notification may result in forfeiture of the prize and, in such case Sponsor may randomly select an alternate Selected Entrant from among the remaining eligible entries. Selected Entrants may also be sent a declaration of eligibility / liability / publicity release (“Release”). Unless restricted by law, Selected Entrants will be required to complete and return the Release within five (5) days from the date of notification. An alternate Selected Entrant may be randomly selected from among the remaining eligible entries if a Selected Entrant: (i) cannot be reached; (ii) fails to obtain all signatures on the Release and to return the documents in a timely manner as required pursuant to these Official Rules; or (iii) cannot accept or receive the prize for any reason.

8. LICENSE: As a condition of entry, Entrant hereby grants to Sponsor a non-exclusive, perpetual, irrevocable, worldwide, transferable, sublicensable, and royalty free license to use, modify, reproduce, prepare derivative works of, distribute, perform, and display the Submission in any and all media throughout the world and for whatever purpose Sponsor deems. If Entrant is a Selected Entrant, instead of the license described above, Entrant grants to Sponsor an exclusive, perpetual, irrevocable, worldwide, transferable, sublicensable, and royalty free license to Sponsor to use, modify, reproduce, prepare derivative works of, distribute, perform, and display the Submission in any and all media throughout the world and for whatever purpose Sponsor deems.

ENTRANTS WILL NOT BE SPECIFICALLY PAID FOR THEIR SUBMISSIONS or for granting Sponsor any of these rights.

9. Publicity: Sponsor reserves the right to use the name, likeness, and/or account ID of any Entrant, for publicity purposes prior to, during, or after the Sweepstakes end date, in any media, throughout the world, in perpetuity, but only in connection with publicizing the Sweepstakes, without any compensation or prior review unless specifically prohibited by law.

At any time before, during or after the Sweepstakes Period, Sponsor may, in its discretion, choose to post or distribute one or more Submissions, the creator’s name and profile information online (including Facebook pages, Twitter feeds, YouTube channels, and third-party websites) for promotional and entertainment purposes only. Posting of this/these Submission(s) will not mean that said Submissions are eligible to win or are a Selected Entrant. Entrant understands



that users of these sites may share, comment on (including negatively), and re-post their Submissions. Any requests by Entrants to have a Submission removed from consideration will be accommodated to the extent practically possible. Sponsor is not responsible for third party re-posting of Submissions.

10. General Conditions: By participating, Entrants agree to be fully and unconditionally bound by these Official Rules and the decisions of Sponsor and waive any right to claim ambiguity in the Sweepstakes or these Official Rules. Any portion of the Sweepstakes may be canceled, suspended and/or modified, in whole or in part, if in our opinion any fraud, technical failure or other factor beyond our control impairs the integrity or proper functioning of the Sweepstakes. Sponsor reserves the right in its sole discretion to disqualify any individual who is found to be tampering with the entry process or the operation of the Sweepstakes, to be acting in violation of these Official Rules, or to be acting in an unsportsmanlike or disruptive manner, or with the intent to disrupt or undermine the legitimate operation of the Sweepstakes, or to annoy, abuse, threaten or harass any other person, and Sponsor reserves the right to seek damages and other remedies from any such person to the fullest extent permitted by law. Entrants may not enter with multiple identities or use any automated system, bot or other device or artifice to enter or obtain more than the maximum number of qualified entries. Sponsor reserves the right at its sole discretion to terminate the Sweepstakes and, if terminated, at its discretion, select the potential winner(s) in a random drawing from among all eligible, non-suspect entries received prior to action taken. Unclaimed prizes will not be awarded. All tax liabilities arising from this Sweepstakes will be the sole responsibility of Selected Entrants. Any attempt to deliberately damage or undermine the legitimate operation of the Sweepstakes may be in violation of criminal and civil laws and will result in disqualification from participation in the Sweepstakes. Should such an attempt be made, Sponsor reserves the right to seek remedies and damages (including attorney fees) to the fullest extent of the law, including criminal prosecution. 11. Limitations of Liability: Selected Entrants agree to release, discharge, indemnify and hold harmless Sponsor and Affiliates. Sponsor and each of their respective officers, directors, employees, representatives, agents and Affiliates (collectively "Releasees") from and against any claims, damages, disability, attorneys' fees, and costs of litigation and settlement, as well as any liability due to any injuries, damages or losses to any person (including death) or property of any



kind resulting in whole or in part, directly or indirectly, from: (i) use, redemption, acceptance, possession, ownership, or misuse of any prize, (ii) participation in any activity, event, or excursion offered in connection with the prize, (iii) use of any facility, service and/or accommodation related to the prize, or (iv) participation in any Sweepstakes-related activity or participation in this Sweepstakes. The Releasees shall not be liable for: (i) late, lost, delayed, misdirected, incomplete unreadable, inaccurate, garbled or unintelligible entries, communications or declarations, regardless of the method of transmission; (ii) telephone system, telephone or computer hardware, software or other technical malfunctions, lost connections, disconnections, delays or transmission errors; (iii) data corruption, theft, destruction, unauthorized access to or alteration of entry or other materials; (iv) any injuries, losses or damages of any kind caused by the prize or resulting from acceptance, possession or use of a prize, or from participation in the Sweepstakes; or (v) any printing, typographical, administrative or technological errors in any materials associated with the Sweepstakes. Without limiting the generality of the foregoing, Releasees are not responsible for computer malfunctions, network connections, email delivery problems, systems failure or incompatibility, typographical, technical or keystroke errors, or interruptions in your internet service, and for incomplete, illegible, misdirected, misprinted, late, lost, damaged or stolen notifications.

In the event Sponsor is prevented from continuing with the Sweepstakes as contemplated herein by any event beyond its control, including but not limited to fire, flood, earthquake, explosion, labor dispute or strike, act of God or public enemy, or any federal, state or local government law, order, or regulation, or other cause not reasonably within Sponsor's control (each a "Force Majeure" event or occurrence), then subject to any governmental approval which may be required, Sponsor shall have the right to modify, suspend, or terminate the Sweepstakes. The invalidity or unenforceability of any provision of these rules shall not affect the validity or enforceability of any other provision. In the event that any provision is determined to be invalid or otherwise unenforceable or illegal, these rules shall otherwise remain in effect and shall be construed in accordance with their terms as if the invalid or illegal provision were not contained herein. Sponsor's failure to enforce any provision in these Official Rules shall not constitute a waiver of that provision.

12. Disputes: Disputes regarding these Official Rules and/or this Sweepstakes will be governed by the internal laws of the State of California. Decisions of Sponsor are binding and final. No claimant in any dispute involving Sponsor shall



be entitled to claim or obtain indirect, punitive, incidental or consequential damages.

13. 14. Privacy: The information you provide will be used only in accordance with Sponsor's privacy policy:

This Privacy Policy describes how your personal information is collected, used, and shared when you visit www.1PasswordConsoleQuest.gg (the "Site").

PERSONAL INFORMATION WE COLLECT

When you visit the Site, we automatically collect certain information about your device, including information about your web browser, IP address, time zone, and some of the cookies that are installed on your device. Additionally, as you browse the Site, we collect information about the individual web pages or products that you view, what websites or search terms referred you to the Site, and information about how you interact with the Site. We refer to this automatically-collected information as "Device Information."

We collect Device Information using the following technologies:

- "Cookies" are data files that are placed on your device or computer and often include an anonymous unique identifier.
 - A visitor may choose not to allow certain types of cookies.
 - A visitor cannot opt out of First Party Strictly Necessary Cookies as they are deployed to ensure the proper function of the Site.

- "Log files" track actions occurring on the Site, and collect data including your IP address, browser type, Internet service provider, referring/exit pages, date/time stamps, and progress in the challenges.
- "Web beacons," "tags," and "pixels" are electronic files used to record information about how you browse the Site.

Additionally when you fill the registration form through the Site, we collect certain information from you, including your name, location, and email address. We refer to this information as "Registration Information". When we talk about "Personal



Information” in this Privacy Policy, we are talking both about Device Information and Registration Information.

HOW DO WE USE YOUR PERSONAL INFORMATION?

We use the Registration Information that we collect generally to fulfill any prizing earned through the Site (including processing your prizing, arranging for shipping, and providing you with prizing confirmations). Additionally, we use this Registration Information to communicate with you and screen for potential risk or fraud.

We use the Device Information that we collect to help us screen for potential risk and fraud (in particular, your IP address), and more generally to improve and optimize our Site (for example, by generating analytics about how our customers browse and interact with the Site, and to assess the success of our marketing and advertising campaigns).

SHARING YOUR PERSONAL INFORMATION

We share your Personal Information with third parties to help us use your Personal Information, as described above. We also use Google Analytics to help us understand how our customers use the Site--you can read more about how Google uses your Personal Information here:

Finally, we may also share your Personal Information to comply with applicable laws and regulations, to respond to a subpoena, search warrant or other lawful request for information we receive, or to otherwise protect our rights.

DO NOT TRACK

Please note that we do not alter our Site’s data collection and use practices when we see a Do Not Track signal from your browser.

DATA RETENTION

When you register through the Site, we will maintain your Registration Information for our records unless and until you ask us to delete this information.

CHANGES

We may update this privacy policy from time to time in order to reflect, for example, changes to our practices or for other operational, legal or regulatory



reasons.
